I am to invite your attention to the references cited.

2) I am to state that orders have been issued in the reference first cited, implementing the recommendations of PGRC, 2019 with reference to the revision of Pay and Pension of 52 categories posts in 20 Departments.

3) In the above Government orders, the Heads of Departments were directed to issue necessary instructions to all Heads of Offices and Sub-ordinate Offices to revise the scales of pay to the employees of 52 categories in 20 departments and re-fix their Pay appropriately in the admissible revised scales of pay and issue necessary revised pay fixation orders for the purpose of drawing salary with effect from 01st November 2020.

4) In the reference third cited, based on the request received, the Pay and Accounts Officers and District Treasury Officers were requested to admit and disburse the salary for the month of November, 2020 based on the Pay drawn in the month of October 2020 and in the reference fourth cited, the Principal Accountant General has also been requested to admit the pension based on the pension drawn in the month of October 2020, and to adjust the excess if any in the Pay/Pension to be disbursed in the subsequent month.

5). Hence, I am to request you to revise the pay scale of the employees as ordered in the Government orders first cited on or before 15.12.2020 and to ensure that the Pay for the month of December 2020 is claimed in consonance with the above Government orders.
