### **ABSTRACT**

Higher Education Department - Annamalai University – Surplus non-teaching staff of Annamalai University in various categories redeployed to various Secretariat / Government Departments and Government Undertakings - Extension of the service for a further period of one year – Orders – Issued.

### **ORDER:**

Due to the administrative mismanagement over the years and also due to appointment of excess staff, which resulted in severe financial burden in Annamalai University, the Government have repealed the Annamalai University Act, 1928 and enacted Annamalai University Act, 2013, by which, the Annamalai University became a State University. The Government had appointed an Administrator to administer and manage the Annamalai University. The Administrator made the following recommendations:-

- Re-deployment of surplus staff,
- revision of Block Grant,
- converting the university into affiliation type,
- takeover of Medical College and Hospital by Government and
- sanction of special financial package to improve the financial position of the Annamalai University.



2. Accordingly in the G.O. first read above, orders have been issued redeploying 2635 surplus non-teaching staff in the categories of Assistant, Junior Assistant, Record Clerk, Driver, Assistant Programmer, Electrician (Gr.I), Office Assistant, Watchman and Gardener in Annamalai University to various Secretariat / Government Departments and Government Undertakings for a period of three years on agreement basis as per Section 19 of Tamil Nadu Government Servants (Conditions of Service) Act, 2016 and as per service regulations of the respective Government Undertakings, subject to certain terms & conditions.

3. In his letter second read above, the Registrar (i/c), Annamalai University has stated that based on the above orders the surplus non-teaching staff of Annamalai University were redeployed to Secretariat / Government Departments and Government Undertakings for a period of three years and that the period of redeployment is due to expire during the month of May 2020. He has further stated that the financial burden of the University is yet to be retrieved and that the University is not in a position to take back the surplus staff and has therefore requested the Government to extend the period of agreement of such non-teaching staff for a further period of 3 years and issue necessary orders, in this regard.

4. The Government after careful examination of the above proposal of the Registrar(i/c), Annamalai University hereby order extension of the services of the 2635 surplus non-teaching staff in the categories of Assistant, Junior Assistant, Record Clerk, Driver, Assistant Programmer, Electrician (Gr.I), Office Assistant, Watchman and Gardener in Annamalai University who were redeployed to various Secretariat / Government Departments and Government Undertakings for a further period of one year from the next date to the date of completion of three years of the individual on agreement basis as per Section 19 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 and as per service regulation of the respective Government Undertakings, subject to the terms and conditions already issued in G.O. first read above or until further orders, whichever is earlier.

5. The respective Secretariat / Government Departments and Government Undertakings are directed to issue necessary proceedings to each surplus non-teaching staff of Annamalai University to this effect.

6. This order issues with the concurrence of the Finance Department vide its U.O. No. 17740/Edn-I/2020 dated:27.05.2020.

2. In the references 1<sup>st</sup> and 2<sup>nd</sup> cited, orders were issued redeploying 327 surplus non-teaching staff in the categories of Assistant, Junior Assistant, Sweeper, Gardener, Driver and Office Assistant to various Secretariat / Government Departments and 263 surplus non-teaching staff in the categories of Assistant Librarian, Assistant Programmer, Junior Drafting Officer (Civil), Assistant Engineer (Civil), Junior Engineer (Civil), Pharmacist, Junior Assistant, Driver, Marker and Cleaner to Government Departments and Anna University for a period of three years on agreement basis as per Section 19 of Tamil Nadu Government Servants (Conditions of Service) Act, 2016 subject to certain terms & conditions.

3. In the reference 3<sup>rd</sup> cited, orders were issued extending the services of the 2635 surplus non-teaching staff from Annamalai University who were redeployed to various Secretariat/ Government Departments and Government undertakings for a further period of one year on agreement basis u/s 19 of Tamil Nadu Government Servants (CoS) Act, 2016.

4. In the reference 4<sup>th</sup> cited, the Registrar (i/c), Annamalai University has requested the Government to extend the agreement period of 327 surplus non-teaching staff in the categories of Assistant, Junior Assistant, Sweeper, Gardener, Driver and Office Assistant to various Secretariat / Government Departments for a period of three years vide G.O. (Ms) No. 278 Higher Education (H1) Department dated 25.09.2017 and 263 surplus non-teaching staff in the categories of Assistant Librarian, Assistant Programmer, Junior Drafting Officer (Civil), Assistant Engineer (Civil), Junior Engineer (Civil), Pharmacist, Junior Assistant, Driver, Marker and Cleaner to Government Departments and Anna University for a period of three years vide G.O. (Ms) No.363 Higher Education (H1) Department dated: 27.12.2017, whose services come to an end between September 2020 and December 2020.

5. In this connection, it is informed that extension of services of 327 surplus non-teaching staff in the categories of Assistant, Junior Assistant, Sweeper, Gardener, Driver and Office Assistant who were redeployed to various Secretariat / Government Departments for a period of three years vide G.O. (Ms) No. 278 Higher Education (H1) Department dated 25.09.2017 and 263 surplus non-teaching staff in the categories of Assistant Librarian, Assistant Programmer, Junior Drafting Officer (Civil), Assistant Engineer (Civil), Junior Engineer (Civil), Pharmacist, Junior Assistant, Driver, Marker and Cleaner who were redeployed to Government Departments and Anna University for a period of three years vide G.O. (Ms) No.363 Higher Education (H1) Department dated: 27.12.2017, whose services come to an end between September 2020 and December 2020 are already covered in G.O. (1D) No.76, Higher Education (H1) Department, dated 27.05.2020, wherein orders were issued extending the services of the 2635 surplus non-teaching staff from Annamalai University who were redeployed to various Departments of Secretariat / Government Departments, Government Undertakings and Anna University for a further period of one year on agreement basis u/s 19 of Tamil Nadu Government Servants (Cos) Act, 2016. Hence, no separate order is necessary for extending the services of above surplus non-teaching staff.

6. In view of the above, the respective Departments of Secretariat / Government Departments / Anna University are directed to issue necessary proceedings to each surplus non-teaching staff of Annamalai University to this effect based on G.O.(1D) No.76, Higher Education (H1) Department, dated 27.05.2020. ### ORDER:

In G.O. first read above, orders have been issued redeploying 2635 surplus non-teaching staff of Annamalai University in various categories to various Secretariat / Government Departments and Government Undertakings.

2. In G.O. second read above, orders were issued redeploying 363 surplus non-teaching staff of Annamalai University in various categories to various Secretariat and Government Departments.

3. In G.O.s third and fourth read above, orders have been issued redeploying 327 and 263 surplus non-teaching staff of Annamalai University in various categories respectively to various Secretariat / Government Departments, Government Undertakings and Anna University.

4. In G.O. fifth read above and in letters sixth and seventh read above, on completion of three year period of the above mentioned non-teaching staff, orders have been issued extending the services for a further period of one year.



5. In the letter eighth read above, the Registrar (i/c), Annamalai University has stated that the extension period of one year of the above mentioned non-teaching staff issued in G.O. and letters fifth to seventh read above is ending between May 2021 to July 2021 and July 2021 to December 2021. He has therefore requested the Government to make arrangement for continuance of the services of redeployed non-teaching staff whose tenure is ending between May 2021 to July 2021 and July 2021 to December 2021 for further period of three years.

6. The Government after careful examination of the above proposal of the Registrar(i/c), Annamalai University and based on the remarks of the Finance Department hereby extend the services of the surplus non-teaching staff of Annamalai University who were redeployed to various Secretariat / Government Departments, Government Undertakings and Anna University, whose services were extended in G.O. and letters fifth to seventh read above, for a further period of one year from the next date to the date of completion of one year on agreement basis, as per Section 19 of Tamil Nadu Government Servants (Conditions of Service) Act, 2016, regulations of the respective Government Undertakings and Acts / Statutes / Ordinances / Regulations of the Anna University, subject to terms and conditions already issued in G.O.s first to fourth read above.

7. The respective Secretariat / Government Departments, Government Undertakings and Anna University are directed to issue necessary proceedings to each surplus non-teaching staff of Annamalai University to this effect.


