ORDER:

In the Government of India, Ministry of Home Affairs (Disaster Management Division) Lr.No.33-4/2020/NDM-1, dated 14.3.2020, it has been informed that the Central Government keeping in view of the spread of COVID-19 Virus in India and the declaration of COVID-19 a pandemic by the World Health Organization (WHO), by way of a special onetime dispensation, has decided to treat it as a notified disaster for the purpose of providing assistance under SDRF. The list of norms of assistance for containment of COVID-19 in India, eligible from SDRF has also been communicated by Government of India vide it's Letter Nos. 33-4/2020 - NDM-I Dated: 14.03.2020 and 28.03.2020. The Government of Tamil Nadu vide its Notification No.118 dated 14.03.2020, (G.O.Ms.No.95, Health and Family Welfare (P1) Department, dated 13.3.2020) have declared that Corona Virus Disease (COVID-19) as a notified disease in the State of Tamil Nadu.

2. Earlier, the Principal Secretary/ Commissioner of Revenue Administration has sent a proposal sent for sanction of Rs.36,07,87,743/- to the Commissioner, Food Safety and Drug Administration for providing accommodation and Food to Doctors, Staff Nurses, and other Paramedical Staffs working in isolation wards of Government institutions for 27 days from 05.07.2020 to 31.07.2020 has been examined by Government.

3. In this regard, it is pointed out that the funds are being sought at the same ceiling rate of Rs.2,500/- per day per doctor and Rs.1,500/- per day per nurse and that these rates were provided as indicative ceiling rate and it is unlikely that the rate would be the same for Chennai City and for small centres. Further, it is pointed out that as ascertained from the Additional Director, FSDA Department the rates vary from district to district and the actual requirements is much lower. Accordingly the Principal Secretary/Commissioner of Revenue Administration has been requested to examine the above points and send the following details to the Government.

- i. To obtain the actual requirement for July, 2020.
- ii. To ascertain the spill over amounts from sanctions in April, May and June 2020, and
- iii. Sanction issued for July, 2020 and, if possible, August 2020 based on actuals.

4. The Principal Secretary/ Commissioner of Revenue Administration has stated that the Designated Officers have submitted the compiled proposal for funds based on the fund proposals provided

by the Dean of Medical College and Joint Director Medical Services at concerned Districts with the approval of District Collector. Based on these proposals, funds have been requested and sanctioned by the Government from SDRF as detailed below:-

The funds have been distributed to all the districts as per their proposal for demand. But due to the unexpected increase or decrease in the COVID cases, 21 Number of Districts had total balance of Rs.5,63,59,913/- on 04.07.2020. As the process of provision of Food and Accommodation is continued, those Districts continue to utilize the balance funds. He has stated that the balance is Rs.1,05,27,550/- as on 13.08.2020.

5. The Principal Secretary/Commissioner of Revenue Administration has also stated that the Commissioner of Food Safety and Drug Administration had stated that since all districts have been continuing the services of Food and Accommodation without fund from 05.07.2020 to till date on credit basis and as it will be difficult for all the 31 districts to continue the services without any fund further, he had requested to sanction Rs.78,92,46,110/- to carry out the activity for 27 days from 05.07.2020 to 31.07.2020. In continuation to this, necessary proposal was sent to the Government for sanction of Rs.36,07,87,743/- to the Commissioner, Food Safety and Drug Administration for providing accommodation and Food to Doctors, Staff Nurses, and other Paramedical Staffs working in isolation wards of Government institutions for 27 days from 05.07.2020 to 31.07.2020.

6. The Principal Secretary/Commissioner of Revenue Administration has further stated that accordingly, the details were sought from the Commissioner, Food Safety and Drug Administration and he has sent a detailed report district-wise/ month-wise and

requested to sanction a total sum of Rs.129,73,07,648/- towards provision of accommodation and food to Doctors, Staff Nurses, and other Paramedical Staffs working in isolation wards of Government Institutions from 05.07.2020 to 31.08.2020 as detailed below:-

The report of the Commissioner of Food Safety and Drug Administration is summarized as detailed below:-

i. Actual Requirement for July 2020

Previously the tentative requirement has been calculated based on the proposals given by Deans, Joint Directors Medical and Rural Health Services and case load and arrived as Rs.78,92,46,110/- (after deducting the spill over from previous sanctions) for the period from 05.07.2020 to 31.07.2020. Now, the actual expenditure is arrived as Rs.59,01,61,856/- (after deducting the spill over from the previous sanctions). The actual requirement is short of Rs.19,90,84,254/-

ii. Spill over amount from previous sanction:

The balance amount from the previous sanction is arrived as Rs.5,63,59,913/- as on 04.07.2020. The amount is deducted from the actual expenditure to calculate the required amount for the period 05.07.2020 to 31.07.2020.

iii. Sanction issued for July, 2020 and August 2020.

No fund has been sanctioned towards this activity for the month of July (05.07.2020 to 31.07.2020) and August and detailed verification has been carried out by the Food Safety and Drug Administration Department and the rates for which food and accommodation were scrutinized. Negotiations were done with Food Business operators. Except Corporations and certain districts, the expenditure towards the food and accommodations is reduced below the ceiling rate of Rs.2500 per day per doctor and Rs.1500 per day per Nurse as fixed by the Government. The abstract is given below:-

The Commissioner of Food Safety and Drug Administration has, therefore, requested to sanction a sum of Rs.129,73,07,648/- towards provision of accommodation and food to Doctors, Staff Nurses, and other Paramedical Staffs working in isolation wards of Government institutions for a further period from 05.07.2020 to 31.08.2020 after deducting the balance amount available with the Commissioner, Food Safety and Drug Administration as detailed below:-

The Principal Secretary/Commissioner of Revenue Administration has requested that an amount of Rs.129,73,07,648/- may be sanctioned to the Commissioner, Food Safety and Drug Administration for providing accommodation and Food to Doctors, Staff Nurses, and other Paramedical Staffs working in isolation wards of Government institutions for a further period from 05.07.2020 to 31.08.2020.

7. The Government after careful examination accept the proposal of the Principal Secretary/Commissioner of Revenue Administration and based on the approval of State Executive Committee accord sanction an amount of Rs.129,73,07,648/- (Rupees One hundred and twenty nine crore seventy three lakh seven thousand six hundred and forty eight only) from State Disaster Response Fund (SDRF) to the Commissioner, Food Safety and Drug Administration for providing accommodation and Food to Doctors, Staff Nurses, and other Paramedical Staffs working in isolation wards of Government institutions for a further period from 05.07.2020 to 31.08.2020.

8. The above expenditure sanctioned in Para 7 above shall be debited to the following head of account :-
